The SOHPS' goal is to further the study of the history and architecture of the Village of South Orange. The students shared their award winning essays at the South Orange Local History Fest held earlier this month.

Bonita Samuels, Principal of Marshall School, was one of 20 elementary and middle school principals across the nation to receive a "Champion Creatively Alive Children" school grant. Crayola and the National Association of Elementary School Principals (NAESP) selected 20 schools to receive the grants, which will fund innovative programs aimed at fostering children's critical thinking, creativity, collaboration, and communication skills through arts education. Ms. Schodowski was nominated as an "exceptional early childhood special educator," who "engages with families in a way that builds trusting and respectful partnerships." NJDEC stated that they were "excited to honor a teacher who puts such high priority on the needs of her students and their families."

The Action Research Team at Marshall School was selected to participate in the MSUNER Action Research Project for 2014-2015. SUPERINTENDENT'S MONTHLY UPDATE

Goal 1 Student Learning:

- Tonight's agenda includes updates and presentations on several important items related to student learning, including:
 - o The Office of Civil Rights (OCR) Resolution Agreement/American Civil Liberties Union (ACLU) Complaint
 - o Preparation for PARCC Testing
 - o Gifted and Talented Strategy
 - o An update on the Special Education Department
- Special Education staff visited the Westfield Early Childhood Center, which is part of the Westfield Public Schools, to observe the type of program which we are preparing to launch at Montrose School in September 2015.
- The focus schools, Maplewood Middle School, South Orange Middle School and Clinton School hosted the Regional Achievement Team for walk throughs to measure progress toward meeting the goals in each respective school.
- On Friday, 11/21, a group of 35 10th 11th, 12th graders visited Rider University & The College of New Jersey to learn more about the Educational Opportunity Fund (EOF). EOF provides additional financial, academic, and social support to financially eligible students and boasts the highest graduation rates in the state. The trip was organized and run by the CHS guidance department. This year, several of our CHS EOF students who were graduates of the class of 2014 have already reported back that they are having successful first semesters
- The use of classroom brain interventions have skyrocketed, thanks to the introduction of GoNoodle. These 3-5 minute interventions have been linked to better academic performance across the country. As an incentive, each month, the teacher that used the most activities is awarded a \$300 classroom equipment package thanks to the PEP grant.

Goal 2 Professional Staff:

- 26 teachers participated in the Learning Walk training followed by classroom visits, which took place October 27, 28, and 29. The final Learning Walk training for this school year will take place on December 9, 10 and 11. Special thanks to the staff and administrations of all the schools for opening up their classrooms for these visits.
- As an extension of the Learning Walks, SOMS is in the process of implementing teacher-led learning walks for the rest of the school year. 20 SOMS teachers who were already trained by the district in learning walks will participate in this professional development activity. These teachers will visit each other's classrooms to provide feedback to their peers, using the Learning Walk feedback protocol.
- Five of CHS's academic departments spent part of the November 3 professional development day working on discussions and planning for the Excellence by Design Middle States Accreditation process
- All departments and all grade levels at both middle schools have planned units based on IB principles. Many thanks to the MS principals, supervisors and teachers and MYP coordinators.

 Authorization visits are planned and will take place as scheduled.
- Several members of the administrative team visited the Dwight School in NYC. The purpose was to observe IB in practice and meet with administrators to share ideas and resources.

Goal 3 Engagement and Outreach:

• The revised 9th grade Preview Night at CHS brought over 700 people (8th grade families, parents/guardians) who enjoyed artistic performances, and saw a presentation from Principal Aaron about the academic, athletic, and extracurricular activities that await freshmen at CHS. The preview night was the first step in on-going, year-long programming to introduce 8th graders and their families to CHS, and will continue in the early part of the new year with communication about scheduling at the high school, 9th grade elective choices, clear communication about level placements, and information about summer academic programs. The presentation is now available on the CHS website, and has been sent to each of our district's 8th grade families.

- The Grades 3-5 Curriculum Night took place at Jefferson School on October 27th, 2014. Approximately 125 parents attended 2 workshops on math and language arts on a variety of topics, such as ST Math, problem solving in math and how the Common Core state standards are being addressed in the language arts classroom. Many thanks to all the presenters.
- Interim reports for middle school and elementary school students were sent home to parents. This communication gives parents an idea of how their child is doing in the new school year. Thank you to both elementary and MS staffs for doing this important work.
- Upcoming Parenting Center events include:
 - The Holiday Toy Drive, which is already collecting toys and money for SOMSD families in need of financial assistance during the holidays;
 - "Protecting Our Children Online" with FBI Special Agent Joshua Wilson on December 4th at Tuscan School.

Goal 4 Resource Management:

- Discussion tonight will include the Baseline Budget Presentation. Many thanks to Cheryl Schneider and her staff for their painstaking work in putting these analyses together.
- Also on the agenda this evening is the first reading of an ordinance to approve the refunding of the 2005 and 2008 bond issues. Municipal bond interest rates have dropped allowing us to save a potential of over 3% on these original bond issues. A second reading is planned for the December board meeting and the potential sale of new bonds in the second half of January.
- The business office has been focusing on the completion of the June 30, 2014 audit which will be presented next month and has been working on the beginning phases of the 2015-16 budget development.

Mrs. Daugherty suggested posting the superintendent updates on the district website.

Francois Duverqne Maplewood	Feels there is little feedback to relieve parent concerns with regard to recent lockdown, gang rumors and homecoming issue. Parents received a call that there was a lockdown, but was not notified that the lockdown had ended.
Emilie Zaslow Maplewood Resident	Co-founder of "Odyssey of the Mind" program at Tuscan School, and spoke about strategy for gifted and talented.
Susan Waters South Orange Resident	Asks for support of gifted and talented program.
Lisa Basile Maplewood Resident	Part of a group of parents discussing concerns with the math curriculum. States that over half of the kids in advanced and honors classes have tutors.

Would like to help to find a strong Special Education Director to replace Dr. Barker who is retiring. As a parent and an educator spoke against the gifted and talented program.

Supports comments made by Lisa Basile regarding math program.

Amy Higer Maplewood Parent Spoke about math placement at the beginning of $5^{\rm th}$ grade and the stress it has on students who are worried about which level they will be placed in.

Ellen Dreyer SOMS Parent Spoke about district math program and placement testing. Also concerned about administration of PARCC, the lack of preparation for students with special needs. FAQ's On PARCC says parents can't opt out, but she doesn't believe this is true.

Virginia Lamb Falcone Maplewood Resident Parent of two students who are both strong math students, who are both accelerated, but feels there is lack of support and teaching in the classroom. Students became discouraged and lost confidence in math. Lots of parents are paying for tutors.

Michael Paris Maplewood Parent Spoke about 9th grade social studies and segregated classes, composition of classes and difference in pacing of what happens in classes. Questioned the change in program without Board authorization.

Thandi Center Maplewood Group of parents concerned about district math program. Spoke about inflexibility of the math program and struggling students. Concerned that low level math effects science placement. Asked for additional help from district, but did not get it and had to hire a tutor instead.

Spoke about cultural competency. Thanked Mr. Stern for attending the steering committee of SOMA parents of Students of African descent. Would like SOMA Black Parents Workshop involved in cultural competency.

Esther Sijkind Echoed comments made by Michael Paris about the Maplewood Resident social studies program and is also concerned about the math program.

Gillian Aldridge Echoed what Lisa Basile stated regarding the math Maplewood Parent program. Child tested on summer packet and failed, but was not given a chance to review what was done wrong.

Dr. Gaudelli has many of the same concerns and believes the next Board should address the math issue. Mrs. Wright apologized to every parent feeling frustrated and Stated that doing something about this should be a priority.

- Need to consult the community for input and involvement in discussing recommendations.
- Board should pick consultant and community should be involved once consultant is in place.
- What role do other factors such as socioeconomics play in Achievement Gap?
- This is about harm that was done to African American s.
- The need to do this right and need to engage and listen to teachers.

NOW, THEREFORE, BE IT RESOLVED BY THE SOUTH ORANGE-MAPLEWOOD BOARD OF EDUCATION, IN THE COUNTY OF ESSEX NEW JERSEY (NOT LESS THAN A TWO-THIRDS MAJORITY OF THE FULL MEMBERSHIP OF THE BOARD VOTING IN THE AFFIRMATIVE) AS FOLLOWS:

Section 1. This ordinance is adopted pursuant to N.J.S.A. 18A:24-61.4 for the purpose of authorizing the issuance and sale of one or more series of permanent bonds of the Board of Education, to current refund \$7,240,000 aggregate principal amount outstanding of the Board of Education's School Bonds, Series 2005 (the "Series 2005 Bonds") and advance refund \$9,395,000 aggregate principal amount outstanding of the Board of Education's School Bonds, Series 2008 (the "Series 2008 Bonds", which with the Series 2005 Bonds are the "Prior Bonds"), to fund an escrow for the payment of interest on the Prior Bonds prior to the respective dates of their redemption and to fund a portion of the costs of issuance thereof. The South Orange-Maplewood Board of Education in the County of Essex, New Jersey, is hereby authorized to issue School Bonds in an aggregate principal amount not to exceed \$18,725,000 for the refunding of all or a portion of the principal of, premium and interest on, the Prior Bonds of the Board of Education. The payment of the principal of the Prior Bonds and the refunding payments to be made on the Prior Bonds shall be from the proceeds of the principal of the Refunding Bonds hereinafter described,

which proceeds shall be deposited into a dedicated escrow account and invested in United States Treasury obligations pending the application thereof to the payment of the Prior Bonds.

Section 2. An aggregate amount not exceeding \$195,000 for items of expense listed in and permitted under Sections 40A:2-51(b) and 40A:2-53(a) of the Local Bond Law has been included in the aggregate principal amount of Refunding Bonds authorized herein.

Section 3. In order to finance the costs of refunding and funding all or a portion of some or all of the Prior Bonds in the aggregate principal amounts stated in Section 1 hereof, negotiable refunding bonds, to be designated "Refunding School Bonds, Series 2014 of the South Orange-Maplewood Board of Education in the County of Essex, New Jersey," (the "Refunding Bonds") are hereby authorized to be issued in the aggregate principal amount not to exceed \$18,725,000 pursuant to the School Bond Law of New Jersey (N.J.S.A. 18A:24-1, et seq.) and the Local Bond Law of New Jersey (N.J.S.A. 40A: 2-1, et seq.). The Refunding Bonds shall be issued for such periods and with such terms as approved by the Local Finance Board in the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey (the "Local Finance Board") consistent with the applicable provisions of the foregoing statutes of the State of New Jersey or which comply with the Local Finance Board's rule on bond refundings meeting certain conditions, which is codified in N.J.A.C. 5:30-2.5 (the "Refunding Rule"). The actual principal amount of each maturity of Refunding Bonds to be issued (in the aggregate not to exceed the amount set forth in this Section 3 above) shall be determined by the Local Finance Board or the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey (the "Director") or by the Board's financial advisor, Phoenix Advisors LLC (the "Financial Advisor") in accordance with the Refunding Rule. The Refunding Bonds shall bear interest at a rate or rates per annum as may be hereafter determined within the limitations prescribed by law. The Refunding Bonds shall be sold pursuant to a negotiated sale in order to assure a price or prices consistent with the requirements of the School Bond Law, the Local Bond Law and the Refunding Rule. All matters with respect to the Refunding Bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted by the Board of Education, including the selection of a bond underwriter or group of underwriters.

Section 4. The School Business Administrator of the Board of Education is hereby authorized to determine all details relating to the issuance of the Refunding Bonds and is authorized to submit such details for approval by the Local Finance Board or the Director or to obtain the advice of the Board's Financial Advisor as to compliance with the Refunding Rule. The School Business Administrator of the Board of Education is further authorized to seek proposals from underwriters to determine the terms of the sale and of the Bonds in accordance with N.J.S.A. 40A:2-51 and to assure

the exclusion of the interest payable with respect to the tax-exempt Refunding Bonds and the continued exclusion of interest payable on the tax-exempt Prior Bonds pursuant to Sections 103, 141 to 150 of the Internal Revenue Code of 1986, as amended, together with the applicable Treasury Regulations, promulgated pursuant thereto in proposed temporary or final form. The School Business Administrator shall report the results of the sale in writing to the Board of Education at its next meeting following the sale.

Section 5. A certified copy of this refunding bond ordinance as adopted on first reading shall be filed with the Director prior to final adoption, together with a complete statement in the form prescribed by the Director and signed by the School Business Administrator of the Board of Education as to the indebtedness to be financed by the issuance of the Refunding Bonds authorized herein.

Section 6. The supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk of the Board of Education and a complete executed duplicate thereof has been filed in the office of the Director. Such statement shows that the gross debt of the Board of Education as defined in the Local Bond Law is increased by the authorization of the debt provided in this refunding bond ordinance by an amount not to exceed \$18,725,000 with a maximum deduction from the debt due to the refunding of the Prior Bonds, (i.e. \$16,635,000). The obligations authorized herein will be within all debt limitations prescribed by the School Bond Law. Upon issuance of the Refunding Bonds and determination of the final amount thereof, if less than the \$18,725,000 authorized hereby, an amended Supplemental Debt Statement shall be made and filed, along with any other required filings, and this Board shall, by resolution, approve the cancellation of such amount authorized hereby, which has not been issued.

Section 7. The full faith and credit of the Board of Education are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this bond ordinance.
