#### APPROVAL OF MINUTES

Mr. Eastman declared the minutes of the Executive and Public Sessions of May 14, 2015, May 18, 2015, and public meeting of June 2, 2015 approved as presented.

#### SUPERINTENDENT'S MONTHLY UPDATE - Mr. Memoli

## Goal 1 Student Learning:

- All 3 Focus Schools have conducted their final walkthroughs of the year with state and district representatives. Each school received walkthrough summary reports of trends and recommendations which include strengths, challenges, recommendations and next steps. This information is used in the school improvement plans that are being developed for next year.
- Transition experiences have been taking place to help ease the transition from 5<sup>th</sup> grade to middle school and from 8<sup>th</sup> grade to high school. These have included school visits for rising 6<sup>th</sup> graders, high school peer leader visits to both middle schools, parent orientations, and special invitations to 8<sup>th</sup> grade students with Individualized Education Plans to visit the high school and meet with high school students with IEPs.
- Senior Awards Night took place on June 3<sup>rd</sup> with 75 different types of awards honoring more than 100 students for excellence, leadership, achievement, and improvement. Categories included the National Merit Scholarship Program, U.S. Armed Services Awards, Principal's Recognition Awards, community awards, scholarships, and prizes from every academic department.
- The Parenting Center hosted a student forum for 25 Maplewood Middle School 7<sup>th</sup> and 8<sup>th</sup> graders to discuss issues related to race and students' experiences in classrooms, playgrounds and in the larger community. The forum was facilitated by Columbia High School teacher Mr. TJ Whitaker, and guided by trained high school students who have spent the year in the service club, "Diversity Rocks". A similar program will take place at South Orange Middle School later this week.
- ullet Registration for summer programming is ongoing. This includes step up classes in math, Cougar Prep for rising  $9^{th}$  graders identified by middle

- school staff, social skills classes, and extended school year programs for elementary students who require ongoing support during the summer.
- Public school districts are required to go through the New Jersey Department of Education's Quality Single Accountability Continuum (QSAC) review every three years. According to the State, we did not meet the required 80% or better scoring criteria in the area of Instruction and Program, losing points in the area of curriculum alignment to the Common Core State Standards. Upon receiving the results, our District immediately appealed this decision. While we still maintain that our curricula are indeed aligned to the Common Core State Standards, since the district did not meet the required points, a QSAC District Improvement Plan is required to be submitted to the State by September 1, 2015. This plan will be brought forward to the Board for approval at the August meeting.
- We are looking forward to celebrating the graduation of the Class of 2015. Members of the class of 2015 are matriculating into more than 110 different institutions of higher learning this year.

#### Goal 2 Professional Staff:

- 45 teachers and administrators completed two full days of intensive training on Restorative Justice. The goal is to develop a broader and deeper toolkit for responding to discipline issues, to reduce suspensions, and to close the discipline gap. A coordinating council has been formed with a representative from each of our nine schools, and is planning next steps to bring restorative practices to their schools.
- The District Administrative Team had the final session of a year-long professional development work with Dr. Khyati Joshi on multicultural education and on striving for social justice. A four-day intensive workshop with Dr. Joshi on culturally relevant teaching is being offered this summer. All interested staff members are encouraged to enroll.

## Goal 3 Engagement and Outreach:

- A Community Forum on Communications was hosted by the Community Engagement and Outreach Committee. Thank you to all of the parents and community members who attended and shared feedback on how we can improve in this area.
- A town hall on school safety was held to address parent and community concerns in response to two security incidents. We appreciate the partnership of Maplewood Mayor Vic Deluca, South Orange Village President Sheila Collum, Maplewood Police Chief Robert Cimino and South Orange Police Chief James Chelel. A special parent meeting also took place at Maplewood Middle School to address school-specific concerns, and engage parents as partners in promoting a positive school environment.
- School in Action Nights took place for both Maplewood Middle School and South Orange Middle School. Parent orientations also took place at both schools for incoming 6<sup>th</sup> grade families.
- The second in a series of community forums on Developing a Roadmap to Access, Equity and Excellence will take place at South Orange Middle School. This will be conducted by Sage Educational Consultants in response to the District's Resolution Agreement with the Office of Civil Rights.

## Goal 4 Resource Management:

- We are grateful to all of the PTAs and HSAs for their incredible partnership. They each raise money every year to support our schools in a variety of ways. Playground initiatives are among the most costly and significant ways that the elementary school PTAs offer their support, when old equipment becomes unusable. On for approval tonight is a very generous donation of \$105,000 from the Jefferson PTA to replace their old wooden play structure which was condemned last fall. The Jefferson and Marshall PTAs worked together on a number of different fund raisers throughout the year to purchase a new, safer, and more developmentally appropriate playground. We are looking forward to seeing the new playground when it is unveiled this fall.
- Registration Update:
  - o We understand that there are some concerns with class size in specific grades at specific schools. Historically, over the summer months, enrollment numbers fluctuate daily as people move in and out of the district. We are watching enrollment numbers very carefully each day and will make the appropriate decisions moving forward that are best for our students and staff and are in keeping with our Board policies and our budget allocations.
  - o Open registration will go throughout the summer. We encourage people to register their children as soon as they possibly can, so that we can make appropriate class assignments and ensure that we have teachers and sections to accommodate all of our students.

## BOARD PRESIDENT'S UPDATE - Mr. Eastman

Mr. Eastman thanked everyone for their participation in the safety forum. The Board received a letter of appreciation from South Orange Village President for hosting the forum and stated that South Orange is applying for a grant under Cops for Schools.

Ronnie Schwartz Tuscan Parent Asks the Board to keep  $3^{\rm rd}$  grade class size below Board limits and that the Board replace the Humanities position with a  $3^{\rm rd}$  grade position at Tuscan School.

Hannah Edelman SOMEA Spoke on behalf of the Maplewood Middle School staff regarding the June 3<sup>rd</sup> Code Red. Teachers expressed concern that discipline issues have not been addressed. Applauds efforts after the Code Red and asked for an onsite crisis intervention specialist for staff. Also states that people do not feel safe at Maplewood Middle School.

Sarah Morgan Tuscan School Concerned about reduction of  $3^{\rm rd}$  grade staffing at Tuscan School. Students benefit from smaller class size. Increased class size is antithetical to closing the achievement gap.

Alison Bekkedahl SOMS Attended the Town Hall meeting and the follow-up meeting and commends the Board for opening the conversation and the follow-up from the H.S.A.

Zena Hardy South Orange Disappointed that it took three months for her son to receive ear receivers. Son has a 504 accommodation plan and should have been given modified math test but he was given the same test as all other students. Feels teachers are not trained to teach 504 students.

Mr. Eastman thanked everyone who spoke for their comments and commitment to the district.

## DISCUSSION / COMMITTEE REPORTS

## Student Representative Report - Ms. Kritzberg

Ms. Kritzberg is excited for Nina Remially and Filip Saulean, who will be sworn in as the next student representative and the alternate, respectively. Ms. Kritzberg's offers thoughts in her final report:

- o Students are concerned that the number of school trips have been reduced.
- o Need more engagement with student body
- o Should continue to discuss 1<sup>st</sup> period starting at 7:30 a.m.
- o Concerns about the conference period and accessibility
- o Some students do not have needed study hall during the day
- o Students would like more air conditioning at the high school
- o Condition of the bathrooms continue to be a concern

o Need to look at how teachers and administrators abide by 504's.

Ms. Kritzberg indicated that it has been an honor serving as the Student Representative and thanked Central Office and Columbia High School administration for their support. She stated that she learned a lot and was proud to have played a small role in the big work everyone is doing.

#### DISCUSSION

## Policy and Monitoring Committee - Mr. Eastman

Mr. Eastman introduced Ms. Ramsey of Sage Consultants. Ms. Ramsey has been working with the Board since March 2015 in response to an agreement with the Office of Civil Rights. Sage Consultants visited the two middle schools and the high school. Mrs. Ramsey reported that to date they have found that major complaints include the disparate number of students in AP courses. Disparities showing that students of color are underrepresented in high level classes, especially in language arts and math, go all the way down to the elementary level.

The Policy and Monitoring Committee is also looking at the 504 policy and reviewing the security policy.

## District Goals - 2015-2016, 2016-2017, 2017-2018

The committee chairs combined their committee reports with the discussion of District goals.

## GOAL 1:

## Excellence & Equity - Mr. Bennett

The committee did not meet in June due to the community forum which was scheduled for the same night. If the committee met they would have discussed Goal 1 and the removal of references to Individualized Education Plans. There are a lot of changes that need to be made with the changes in testing.

The committee will also discuss Seth Boyden, World Language and the dissatisfaction with the Math Program.

Board member discussion included:

There are several goals about implementing programs but we must also monitor the program continuously to ensure we have a challenging curriculum. The committee should think about a goal that sets a trajectory for math to be Algebra I for all students by  $8^{th}$  grade. This is the state's criteria for college and career ready.

## <u>Policy and Monitoring Committee</u> - Mr. Eastman In addition to the previous update, the Board discussed policy and monitoring relating to district Goal 2. Comments include:

• Keeping language that relates to the goals in the Superintendent's contract.

- Making sure staff feel supported and they have accesss to the Board
- Having a goal to be sure that the Superintendent is seeing that staff are performing evaluations in a timely fashion.

## GOAL 3: Community Engagement & Outreach - Mrs. Wright

The committee discussed many important communication issues including public speaks and holding people accountable. Policies have not been communicated well and the district website needs an overhaul to make it easier for people to navigate and find answers.

The Board discussed Goal 3 language including a milestone to complete a global audit of all district communications and documents.

## Finance, Facilities & Technology - Mrs. Lawson-Muhammad

Focus for this month was on security aspects of the committee. The discussion of items to review are similar to items from the community addressed during the public speak, potion of tonight's meeting. The discussion regarding safety included the following:

- o Review of the New Jersey School Boards best practice and compare to
- o District practices.
- o Address consistency across schools
- o Compare protocols set by district versus the school by school implementation.
- o Make sure there is social support needed
- o Research disaster relief counselors available through the county
- o Consider district resource officers in the schools

The Board also discussed the Goal's language around the budget and the cost of maintaining existing programs.

The committee received and update on the Montrose Early Childhood Center.

## Negotiations Committee - Mrs. Daugherty
