Ms. LoBianco was one of ten candidates whose names will be on the ballot for voting by the membership to fill the five vacant positions on the Board. If selected, Ms. LoBianco will serve on the Board for either two or three years; selection will end by March 19, 2015.

SUPERINTENDENT'S MONTHLY UPDATE

Goal 1 Student Learning:

- On for discussion tonight is an update from CHS Administrators on Middle States Accreditation and the Excellence by Design protocol.
- In early January a team of district administrators, staff, community members and board members visited Rockville Centre's South Side High School. Thank you to the administration, teachers and students at South Side for hosting a very informative day. We observed classrooms and students including the IB program and were very impressed with their commitment to high standards for all students.
- The first two cycle reviews for our three focus schools are complete.

 These reviews include data collection and analysis in math and language

- arts and progress towards the school improvement plans. We are planning the next site visits with the state team.
- Test coordinators, principals and other staff are meeting weekly with Mr. Roth and Ms. Grierson to ensure readiness both technologically and academically for Partnership for Assessment of Readiness for College and Careers (PARCC) testing.
- The 9th grade FAST study hall program is continuing at CHS and will be expanded when the second semester begins to include more students identified as needing academic support in core content areas. Letters for those students are being sent to them and their families this week.
- In the first 15 school days of the FAST program, 24 students participated in 67 structured study sessions, including 16 students who opted to attend extra sessions to which they had not been assigned.
- SOMSD celebrated the legacy of Dr. Martin Luther King Jr. with a host of activities including cultural arts assemblies, the annual MMS MLK Peace March, a family event hosted by the Parenting Center and an invitation to submit work for an online gallery of art and poems.
- A second series of "Conversations at Columbia" was held by and for students on January 16th in the Black Box theater. The topic was Columbia: 2025, and the discussions were framed around a quotation from Martin Luther King, Jr. about progress and moving forward.

Goal 2 Professional Staff:

- Columbia High School hosted an Essex County Principals' roundtable in early January. Principals from Millburn, Livingston, Glen Ridge, Nutley, Bloomfield and Belleville met with Ms. Aaron to discuss issues and share best practices.
- At the January 20th Columbia High School staff meeting, Special Services supervisor Rob Schmidt and members of the child study team and special education teachers shared best practices with their colleagues around the topics of reaching all students with direct instruction methods where appropriate, strategies for students with communication impairments, and strategies for students with ADD/ADHD.
- Teachers at Columbia High School participated in the second round of Friday Lunch and Learn table discussions with Assistant Principal Hewitt leading sessions to share best practices and problems around classroom management and managing student behavior as outlined in the Danielson Framework for Teaching.

Goal 3 Engagement and Outreach:

- 157 parents attended our "Kindergarten Q&A" on Saturday, January 31st. Many thanks to the administrators and teachers who gave up their Saturday morning to welcome our newest families and answer their questions as they prepare their children for kindergarten.
- Columbia High School held a PARCC Information Night that was attended by 106 parents and guardians. The presentation made by Ms. Aaron that night was sent to all families and posted on the CHS website. Parents and families had the opportunity to practice with our Chromebooks and PARCC sample items. Additional PARCC events are scheduled for middle and elementary school families.

Goal 4 Resource Management:

- The business office continues to work on budget development, and has been working with all district administrators to identify needs and priorities for 2015-2016.
- With the recent snow, the facilities department has been very busy with snow removal.
- Sale for refunding the bonds has been rescheduled for tomorrow, and the prospects are good.
- Early registration for kindergarten will begin tomorrow and takes place from February 3, 2015 March 19, 2015. Those not registered by Thursday, March 19, 2015, must wait until Monday, May 4, 2015 to register for kindergarten. Kindergarten parents will receive notification of their child's placement mid-late May, along with their kindergarten orientation notices.

President's Update on Board Goals

Matthew Malespina SOMS 6th grader Concerned that PARCC testing prep is taking away from other learning. Feels that PARCC should not be used to measure how teachers are doing. Should be a policy in place which will allow parents to opt out of the test without penalizing a students.

Ellen Dreyer SOMS Parent Spoke on behalf of SOMath group. Expressed concern that the math program doesn't serve the majority of the students. It is difficult to move up levels and students are labeled from an early age, advanced students are left to figure things out on their own; and the practice of not returning tests doesn't allow students to learn from their mistakes. Parents are left to pay for tutoring, a service that is out of reach for many.

Sam Gomberg CHS 9th grader Talked about the math program and raised concern that teachers are no longer teaching, but leaving students to figure problems out on their own. Tutoring has helped but hopes the program will be corrected for those who cannot pay for tutoring.

Leah Gomberg Maplewood Feels the math program is failing many students in the District. Teachers are handing out worksheets for students to figure out on their own, formulas aren't being taught. This approach does not seem in line with our district equity and excellence goals.

Laurie Tarkin Maplewood Also concerned about the district math program and shared family experiences similar to previous speakers. Urges the district to make a change.

Michael Paris Maplewood Spoke about Level Up placement issues and about a recent OpEd piece in the village green.

States his experience with the district math program is the opposite of other speakers. He has two students in advanced math who did not have trouble with transition, tests have been returned and learning disability needs have been met. His children have had no trouble keeping up.

Annemarie Maini South Orange Echoed concerns of other speakers regarding the math program.

Ms. Aaron presented a Powerpoint presentation on the Middle States Accreditation and spoke about the accreditation process, the timelines, and steps taken to date. As a result by September 2015, a 5-7 year strategic plan for Columbia High School will be developed.

Discussion following the presentation included reviewing the criteria for entry to AP courses, vision for facility plans and what it will look like 10 years from now and if this information gets shared with the middle schools.

Committee reviewed guiding change framework for foreign languages at the middle and high schools to be revisited at a later date. The addition of an academic intervention teacher at Seth Boyden School was also discussed. Additional discussions included PARCC testing and the opt out and parental concerns regarding the district math program.

Communications and Outreach - Mrs. Wright

The committee discussed ways to improve communications and community feedback such as finding out where people look for news regarding the school district and the possible need to put together different communications packages. Discussed bringing back liaison meetings with the superintendent and town officials. Two Bammy award winners, Ms. Malespina and Ms. Butler were invited to the next meeting to discuss use of technology for communications. Other suggestions to improve communication include inviting students into future meetings and looking at other districts with good communication.

Finance & Facilities - Mrs. Lawson-Muhammad

Committee discussed the budget and its alignment with district goals. Technology and PARCC are on schedule. Update on the healthcare task force was given. Building beautification projects reviewed and the potential use by the District of the Marylawn School building, which is currently for sale. The language for a resolution for support of transparency in reporting PILOTS in Governmental Standards Accounting Board (GASB) was discussed and is on the agenda for consideration.
