2016-17 Preliminary Budget - Mrs. Schneider

Mrs. Schneider presented a Powerpoint presentation that included the following information:

- Budget Considerations

- Need to increase revenues including an increase in grant applications.
- Maximizing student enrollment in courses
- What would be the impact of eliminating the healthcare opt out incentive?
- What is driving the increase in out of district placements?
- Budget attempts to align resources with the community priorities.
- Why are we closing the pool when it is operational.
- The whole budget is about students and how we are going to provide services to them.

HEARING OF INDIVIDUALS AND DELEGATIONS

Elissa Malespina South Orange	Concerned that librarians may be cut at focus schools where students need these resources. Will provide the Board with reading materials regarding the Every Student Exceeds Act that allows funding for Library programming to help the District achieve federal funds to keep librarians in place.
Kim Field South Orange	Thanked the Board for the hard work on the budget. Literacy is more important than ever and hopes the Board will reconsider cutting librarians.
Rachel Fisher Maplewood	Understands that cuts have to be made or taxes must be raised. Asks the Board to communicate clearly and do not be afraid to raise taxes.
Gabe Harris Maplewood	Schools were a large part of his decision to move to Maplewood. Disappointed to hear about a budget that has been cut year after year. Agrees with applying for grants and raising taxes, need to increase revenues rather than cutting programs.
Steve Latz Maplewood	It is the Board's role to see that every child receives a thorough and efficient education. Encourage the Board to make sure there are no cuts to academic intervention and to make sure that Seth Boyden School has the resources they need.

Steve Hayek South Orange Spoke about the closing of Columbia High School pool. Columbia is a historical building and there are grants available for funding as well as companies that will donate pumps and other equipment. Ask the Board to reconsider closing the pool and let the swimming club be part of Columbia's future.
