He has made marked improvements in communication, holding town halls, responding in real time to public speaks and replying to all of his emails which given the volume this year must be an herculean task. His presentations at meetings and public events are comprehensive. For example when Dr. Taylor entered the District, he inherited a proposed integration design that seems to have been picked mostly for cost effectiveness.
