I am highly concerned that all children are being forced to wear face coverings for the entire school day. What is the psychological damage of teaching children to fear one another, and to prohibit them from seeing facial expressions? What effects does masking wearing for long periods of time have on immune system for young children, and forcing them to breathe through sweat, spit, dirt, and bacteria rags all day? 480 kids died from the flu in the 2018-2019 season.
