BOARD PRESIDENT'S STATEMENT

The School Board meeting is a business meeting in public not a meeting with the public. Oftentimes it may appear to members of our audience that the Board of Education takes action with very little comment and in many cases a unanimous vote. Before a matter is placed on the agenda at a public meeting, the Administration has thoroughly reviewed the matter with the Superintendent of Schools/Chief School Administrator (CSA). If the Superintendent of Schools/Chief School Administrator is satisfied that the matter is ready to be presented to the Board of Education, it is then referred to the appropriate Board Committee. The Members of the Board Committee work with Administration and the Superintendent to assure that the members fully understand the matter. After the committee discusses the matter, it is presented to the full Board for discussion before any action is taken. Only then, is it placed on the agenda for action at a public meeting.

HEARING OF INDIVIDUALS AND DELEGATIONS

Hello Dr. Taylor and members of the Board of Education.

My name is Malia Herman. I am a Maplewood resident, mother of two and president of SOMA SEPAC, our district's Special Education Parent Advisory Committee.

Our SEPAC Board would like to welcome the new members to the BOE. We look forward to working with you.

As you know, New Jersey Law specifies that "Each District Board of Education shall ensure that a special education parent advisory group is in place in the district to provide input to the district on issues concerning students with disabilities." [New Jersey Administrative Code 6A:14-1.2(h)]

Our district is fortunate to have an active parent-led SEPAC. We meet monthly with the Assistant Superintendent of Special Services and quarterly with the Superintendent to provide feedback on what we are hearing from parents in the special education community. Additionally, two SEPAC board members are a part of President's Council, which meets monthly with Dr. Taylor. We have SEPAC liaisons at each school, and we plan and hold monthly meetings for parents.

However, despite SEPAC being a legally-mandated entity, there is currently no official connection between the BOE and SEPAC. This was not always the case. Only a few years ago, there was a specific board member designated as the liaison to SEPAC. This board member would typically attend our meetings, as well as stay in contact with the SEPAC leadership. We are speaking to you tonight to consider adding that role back.

There are 1,121 children in our district with IEPs, a number that would be higher if you included those with 504s. Our of a district-wide enrollment of 7,000, special education students comprise at least 16 percent, more if you include children with 504s.

With the number of policies that the BOE considers each year, and the number of challenges facing special education children, we feel that it's time for the board to re-instate a liaison to SEPAC.

BOE members are elected by the community to serve the students of our district. We'd like to help you serve them better.

BOARD RETREAT

Good Evening Board Members and members of the public. Harassment Intimidation and Bullying (HIB) are high priority for this district, our Board of Education and Administration. We often discuss HIB cases that rise to the level of review by the Administration and

Board of Education. We have a belief in the growth mindset and to always be improving on our practices and protocols. To that end, with new Board Members, we thought it would be a great idea to bring in vendor LEGAL ONE to give us some expertise and professional development for the Board on this important topic of HIB.

Joanne Butler, In-House Counsel emphasized that HIB is such a big issue that all districts are facing in New Jersey and that this Board is committed to making sure HIB is ideally eliminated. With the monthly reporting that must be given to the Board, it is important that all of Board of Education members understand the legal criteria for what constitutes HIB, the parameters of what can be done as part of an investigation and then as follow-up.
