Board President Wittleder shared the purpose of tonight's Special Meeting. Tonight's meeting was called to discuss the Superintendent. The superintendent received a Rice Notice at least 48 hours in advance of this meeting. Dr. Taylor has made the decision to have any conversations related to his performance in public session instead of closed session this evening. The Board will move to a short closed session to discuss attorney client privilege matters only. We will reconvene thereafter for public speaks and then a discussion about resolutions 4536A-C on the agenda for action evening.

### SUPERINTENDENT'S STATEMENT - Dr. Ronald G. Taylor

I'm speaking to you via video because at 2:15 p.m. today I received the resolutions for this evening. As this is highly unusual and I'm not sure when or if I'll be able to address you again, I took the liberty to record this message. As the community you should be aware of what is occurring in the Governance of your school district. I hope that

everyone received our update earlier today along with responses to SOMEA Leadership's recent action.

For those wondering why we are here on a Friday evening before Fall Break, you should know a few facts. For those who have attended these meetings before you know that I do not normally talk about myself and my own Journey nor my professional challenges but I feel that I owe this to the community and to those who have tirelessly supported this generational work.

I welcome anyone to again peruse those responses to SOMEA's vote of no confidence to see our very thoughtful accurate and factual responses. It's my pleasure to serve. Thank you

Board President Wittleder made a motion seconded by Board Member Malespina to adjourn to Executive Session at 6:32 p.m. to discuss matters of attorney client privilege. The length of the of the Executive session is estimated to be 20 minutes, after which the public meeting of the Board shall reconvene and action will be taken.

### BOARD PRESIDENT'S STATEMENT

The school board meeting is a business meeting in public and not a meeting with the public. Oftentimes it may appear to members of our audience that the Board of Education takes action with very little comment and in many cases a unanimous vote. Before a matter is placed on the agenda at a public meeting, the Administration has thoroughly reviewed the matter with the Superintendent of Schools/Chief School Administrator (CSA). If the Superintendent of Schools/Chief School Administrator is satisfied that the matter is ready to be presented to the Board of Education, it is then referred to the appropriate Board

Committee. The Members of the Board Committee work with Administration and the Superintendent to assure that the members fully understand the matter. After the committee discusses the matter, it is then shared with the other Board members for consideration. Only then is it placed on the agenda for Board discussion and action at a public meeting.

### ITEMS FOR ACTION

At the request of the Board, Attorney Patrick Carrigg addressed the issue raised about lame duck actions. The Board's anticipated actions are all occurring tonight which is during the life of this Board. They do not bind a future board. They are occurring actively tonight and they will continue as long as they are in place during the life of this Board. So, this is not an unlawful action by a lame duck board.

As a second issue, normally personnel matters are all discussed in Executive Session. Employees of the school district are given a notice that the Board of Education will be discussing issues that could impact their terms and conditions of employment. In advance of those discussions the employee has the right to elect to have that discussion occur in public instead of an Executive Session. So, in advance of this meeting, Dr. Taylor did advise that he was requesting that the discussion occur in public session. So, what will occur now basically is the Board will have a discussion that it would otherwise have had in Executive Session. That discussion is among the Board, no one else is a participant to that discussion. Essentially what goes on now is people can see and hear what the board would discuss but cannot participate in it. The topic that could be discussed at the time of this discussion include performance, evaluation, discipline and anything and everything impacting the terms and conditions of Dr. Taylor's employment. This discussion is preceding the motions that are actually later in the agenda. This discussion follows the same Roberts rules.

Board President Wittleder supports the motion to issue notice of nonrenewal of Dr. Taylor's contract because this has been the sentiment of the Board since May of 2023. Board President Wittleder explained the factors that influenced the Board's decision to take action regarding Dr. Taylor's employment, stating our position on the need for a change in leadership has remained steadfast and consistent throughout this process. Board Members engaged in a spirited discussion about Dr. Taylor's contract non-renewal, and the process that led to today's Special Meeting. Board Members shared their thoughts whether in favor or against renewing him while offering detailed explanations for their position and how the non-renewal can positively or negatively impact the District.

Board Member Vadlamani made a motion to sever resolutions 4536A, 4536B and 4536C.

Board President Wittleder made a motion, seconded by Board Member Telesford to move resolution 4536A for discussion and voting. Motion passed unanimously.
