2200 CURRICULUM CONTENT (M)

The Board of Education will provide the instruction and services mandated by law and rules, and the financial resources as necessary for the implementation of a thorough and efficient system of free public education and such other instruction and services as the Board deems appropriate for the thorough and efficient education of the students of this district. The Board shall annually approve a list of all programs and courses that comprise the district's curriculum and shall approve any subsequent changes in the curriculum in accordance with Policy 2200 - Adoption of Courses. The Board shall also approve any alterations in the curriculum as defined in Policy 2220.

For purposes of this Policy "curriculum" means planned learning opportunities designed to assist student toward the achievement of the intended outcomes of instruction. the 2000 policy series, the following definitions will apply:

"Alteration" means any change in content, or a course of study adopted by the Board of Education pursuant to Policy 2220, including changes in (1) rationale or description, (2) scope and sequence, (3) required activities as documented in the adopted curricula, (4) instructional materials or (5) evaluation techniques, which can reasonably be anticipated to change any objectives/proficiencies (intended to be used interchangeably) (6) length of course, (7) credit or graduation requirement changes so adopted by the Board of Education pursuant to Policy 2220.

"Course" is an organization of content and related learning experiences within the subject areas that are offered for the instruction of students.

<u>"Curriculum" is a framework of the skills and knowledge that students are to </u> learn.

"Curriculum Guide/Course of Study" - Used interchangeably, these terms refer to the description, learning objectives, scope and sequence, sample activities and instructional strategies as well as the assessments that comprise the subject areas taught in the district.

"Program" means an organization of curricula and courses across the grade levels in which a subject area is implemented; e.g. Language Arts is a

kindergarten to grade twelve program, while Business Technology is a grade nine to grade twelve program.

In accordance with law, the curriculum shall, at a minimum, include the curricular mandates of N.J.S.A. 18A - Education and N.J.A.C. 6 - Education and all of the New Jersey Student Learning Standards and Cumulative Progress Indicators and the courses required by Policy No. 5460 and N.J.A.C. 6A:8-5 for high school graduation.

The curriculum will be reviewed by the Superintendent and shall, as a minimum, include the curricular mandates of N.J.S.A. 18A – Education, N.J.S.A. 6A – Education, and the New Jersey Student Learning Standards and the courses required by Policy 5460 – High School Graduation and N.J.A.C. 6A:8-5 for high school graduation.

The Superintendent is responsible for implementing the curriculum approved by the Board.

The curriculum shall be consistent with the educational goals and objectives of this district and the New Jersey Student Learning Standards and be responsive to identified student needs. The Superintendent shall, in consultation with staff members, assure the effective articulation of curriculum across all grade levels and among the schools of the district.

The Board directs that the curriculum be consistent with the educational goals and objectives of this district and the New Jersey Student Learning Standards, and be responsive to identified student needs. The Superintendent shall, in consultation with teaching staff members, ensure the effective articulation of curriculum across all grade levels and among the schools of this district. The Superintendent shall further ensure the alignment of the written, taught and tested curriculum in all subject areas and for all grade levels to a wide variety of assessment measures

aimed at improving student achievement and learning.

The district's curriculum and instructional programs shall be systematically defined and regularly

evaluated K-12, and clearly communicated to the school community:

The schools shall have high expectations and clear goals for student learning which shall

be communicated regularly to students, staff, and the community at large.

_

Student progress toward these goals shall be monitored and reported frequently to students, parents, and planners. Outstanding student effort and achievement in all areas of school life shall be encouraged and recognized regularly. Extracurricular activities shall exist to supplement the instructional program. Evaluation of the effectiveness of instructional programs shall be based primarily on student performance of desired outcomes, as well as on the amount of information taught and the manner in which it is presented.

Development, monitoring, evaluation, and changes to all programs shall involve those professionals most directly engaged in implementing them. Leadership in these processes shall be provided by those with professional expertise in the subject area, cognitive development, and instructional strategies. To ensure consistency and continuity, such leaders shall have program responsibility across grades and among buildings.

_

In each school building, the Principal shall provide instructional leadership and manage the building so its operation supports an excellent educational program. The Principal shall be responsible for organizing the school day, staff, and the instructional program so that it maximizes student opportunity for learning. The Principal shall also see to it that budget for the quality and kind of educational supplies necessary for an excellent educational program is requested.

The Superintendent shall ensure that all district support and intervention programs are aligned with the written, taught, and tested curriculum.

-

The Superintendent shall ensure the consistent delivery of the curriculum in all programs and schools.

-

The curriculum shall provide programs in accordance with Board policies and the New Jersey Core Curriculum Content Standards, including but not limited to:

 Preparation of all students for employment or post-secondary study upon graduation from high school;

2. Instruction in workplace readiness skills, visual and performing arts, comprehensive health and physical education, language arts literacy, mathematics, science social studies (including instruction on the Constitution of the United States, United States history, Community Civics, and the geography, history and civics of New Jersey), and World Languages;
3. Continuous access to sufficient programs and services of a library/media facility, classroom collection, or both to support the educational program of all students in accordance with Policy 2530;
4. Guidance and counseling to assist in career and academic planning for all students, in accordance with Policy 2411;
5. A continuum of educational programs and services for all children with disabilities, in accordance with Policy and Regulation 2423;
6. Bilingual education, English as a Second Language, and English language services for students of limited English language proficiency, when the number of such students so necessitates, in accordance with Policy 2423;
7. Programs and services for students at risk who require remedial assistance in accordance with Policies 2414, 2415, and 5460;
8. Equal educational opportunity for all students in accordance with Policies 2260, 5750, and 5755;
9. Career awareness and exploration as required, and vocational education as appropriate;
- 10. Educational opportunities for students with exceptional abilities, in accordance with Policy 2464;

11. Instruction in accident and fire prevention;

12. A substance abuse prevention program;

13. A program for family life education; and
