## 2220 ADOPTION OF COURSES

The Board of Education shall provide a comprehensive instructional program to serve the educational needs of the children of this district by the adoption of courses of study, and shall allocate the resources needed to effectively deliver an aligned written, taught and tested curriculum in all instructional areas.

No course of study will be taught in this district unless it has been formally adopted by the Board. The Board shall determine which units of the instructional program constitute courses of study and are thereby subject to the adoption procedures of the Board. No course of study shall be altered without approval of the Board.

Each course of study shall include minimum course proficiencies. In order to satisfactorily complete a course of study, a pupil must demonstrate mastery of the established minimum level of course proficiencies. Core course proficiencies shall align with State Core Curriculum Content Standards and with the National Common Core Standards and shall include, but need not be limited to, proficiencies established by the State Board of Education in the curriculum areas of mathematics; natural or physical sciences; English; social studies; foreign languages; fine, practical, and performing arts; career education; and health, safety, and physical education.

The Superintendent is responsible for the development of a district curriculum management plan or a plan that includes a preK-12 scope and sequence for core content areas and for the continuous evaluation and regular formal assessment of the courses of study against the educational goals of the <a href="Board\_Board\_pursuant\_to\_Policy#2610">Board\_Board\_pursuant\_to\_Policy#2610</a> and shall recommend to the Board such new or altered courses of study as are deemed to be in the best interests of the pupils of this district. The Superintendent's recommendation will include the following information about the proposed course of study:

1. The specific objective of the course of study and the relationship of the course to the educational goals\* adopted by the Board;
