

2530 RESOURCE MATERIALS

The Board of Education shall provide resource materials to implement school district's and school educational goals and objectives to meet as student needs dietate as district resources permit. Such Resource materials include, but are not limited to, reference materials; fiction and nonfiction books; maps; audio and audio-visual materials; pamphlets; periodicals; pictures; online references; other supplementary titles; print and non-print materials, such as audio and electronic books, electronic databases, and other sources of information for use by students that are not designated as textbooks. Resource materials are not library material as defined in N.J.S.A. 18A:34A-3 and Policy and Regulation 2535.

~~While the selection of resource materials involves many people, including certified library media specialists, teachers, students, supervisors, administrators, and community members, the responsibility for coordinating and recommending the selection and purchase of library resource materials rests with the certificated library media specialists. All recommendations will be forwarded to the Principal or designee for consideration. The Principal will make a recommendation to the Superintendent, who after review will submit to the Board of Education for final approval.~~

~~Educational goals of the school district, individual student learning modes, teaching styles, curricula needs, faculty and student needs, and existing materials should all be considered in selecting resource materials. Guidelines for the evaluation and selection of resource materials should include the following:~~

~~1. Material will be suited to the varied backgrounds, interests, abilities, reading levels, and maturity levels of the students to be served, who will be provided maximum accessibility to these materials;~~

~~2. Wherever possible, materials will provide major opposing views on controversial issues so that students may develop under guidance the practice of critical reading and thinking;~~

~~3. Materials will represent the many religious, ethnic, and cultural groups, as well as persons of a diversity of gender, gender identity, and sexual orientations, and their contribution to this country and the world, thereby enabling students to develop diverse intellectual integrity;~~

~~4. Material will be factually accurate and of genuine literary interest, of aesthetic value, and ethical standards;~~



- ~~5. Material will be of a quality and durability appropriate to their intended uses and longevity;~~

- ~~6. Material will relate to, support, and enrich the courses of study adopted by the Board, and will align with the written, taught and tested curriculum, as updated; and.~~

- ~~7. Materials will be reviewed for content, context and cognitive type alignment to the district's curriculum and assessment.~~
 - ~~_____ The school libraries/media will:~~
 - ~~1. provide qualified personnel, including certified library media specialists, to serve teachers and students;~~
 - ~~2. provide necessary access, space and personnel to implement such a program;~~
 - ~~3. provide a comprehensive collection of instructional materials selected in compliance with basic written selection principles;~~
 - ~~4. provide materials and instruction for teachers and students that will encourage growth in knowledge, and that will develop literary, cultural and aesthetic appreciation, and ethical standards; and~~
 - ~~5. solicit recommendations from faculty and students on resource materials to purchase.~~

The Superintendent will develop regulations for the selection of resource materials pursuant to Regulation 2530 that provide for the effective consultation of ~~library and~~ teaching staff members at all appropriate levels; ~~2~~ ensure that the Board's budgetary allotment for resource materials is efficiently spent and ~~equitably~~ appropriately distributed throughout the instructional program and the district; ~~2~~ and ensure an inventory of resource materials that is well balanced, ~~diverse, and well-rounded in coverage of~~ subject, types of materials, and variety of content. ~~The regulations will allow for these materials to be free of all late fees and fines, other than the replacement cost of the material(s) if lost, pursuant to policy 5513 Care of School Property.~~

~~The certified library media specialists will conduct a periodic review of resource materials in their collection and remove (aka "weed") materials no longer deemed appropriate based on their continued usefulness, relevance to the curriculum, representation of the needs and interest of all grade levels, subject areas, and departments and based on the content, types of materials and manner of presentation. Standard materials subject to frequent use that are worn or missing should be replaced periodically. The library media specialist will evaluate with the concurrence from the school principal, Superintendent the continuing effectiveness and utility of resource materials and recommend to the Board the removal of those materials that no longer meet the standards set forth in this policy.~~

In the event that materials are questioned, the principles of intellectual freedom, the right to access materials and the integrity of the certificated library media personnel must be defended. Any request for the removal of resource materials will be governed by Policy No. 9130 on public complaints.~~

The Superintendent will evaluate resource materials and recommend to the Board the removal of resource materials that no longer meet the standards set forth in Regulation 2530 and this Policy. Any request by an individual for the removal of resource materials will be governed by Policy and Regulation 9130.
