3240 PROFESSIONAL DEVELOPMENT FOR TEACHERS AND SCHOOL LEADERS

The Board of Education encourages all teaching staff members to pursue a program of continuing professional development by course work or matriculation in institutions of higher learning, participation in workshops and conferences, membership in professional organizations, and/or independent scholarship.

The Superintendent may permit tTeaching staff members may be permitted to visit other schools and classrooms; attend local, regional or national conferences; and participate in committees, workshops, and panels, both within and outside the district. Such activities must demonstrate a nexus between the activity and the employee's professional responsibilities. Requests for participation in such professional development opportunities activities must be submitted in writing to the Superintendent or designee for approval. and are subject to any procedures agreed upon between the Board and any collective bargaining unit. In addition, the Board of Education must approve all travel expenditures in accordance with N.J.S.A. 18A:11-12 and the State of New Jersey Department of the Treasury, Office of Management and Budget Circulars 08-19-OMB and 06-14-OMB (OMB Circulars) and any superseding circulars and any additional requirements set forth in N.J.A.C. 6A:23A-7 et seq.

A teaching staff member who has been granted time off and/or reimbursed for professional development activity shall submit to <u>the Superintendent or designee</u>, <u>their</u> <u>Supervisor</u> with a copy to the <u>School</u> Business Administrator/<u>Board Secretary</u>, within ten working days, a brief written report <u>that includes</u> of the activity including the primary purpose of the travel, the key issues addressed <u>at the event</u>, and their relevance to improving instruction or the operations of the <u>school</u> district.

All active teachers, defined as staff whose positions require possession of the instructional or educational services certificates in accordance with N.J.A.C. 6A:9C-8, through $10,11_7$ and 13 and all active school leaders serving on a permanent or interim basis whose positions require possession of the Chief School Administrator, Principal, or Supervisor endorsement in accordance with N.J.A.C. 6A:9B-12 shall comply with the professional development requirements as outlined in NJ.J.A.C. 6A:9C-4.1-15.1 et seq.

To meet the professional development requirement, each teacher shall be guided by an individual Professional Development Plan (PDP), which shall include at least twenty hours per year of qualifying activities as outlined in N.J.A.C. —6A:9<u>C</u>-15.-4.4. The PDP shall be developed by each teacher's supervisor in consultation with the teacher and shall align with the Professional Standards for Teachers in N.J.A.C. 6A:9-3.9 and the Standards for Professional

Learning in N.J.A.C. $6A:9\underline{C-3.3}$ The PDP shall be effective for one year, <u>updated annually</u>, and shall include₇ at least the minimum requirements outlined in N.J.A.C. $6A:9\underline{C-4.4}$ -15.4(c).

The Board shall monitor and enforce the professional development requirements for teachers and school leaders set forth in N.J.A.C. 6A:9C-4.1-15 et seq. and shall actively assist and support the provision of opportunities and resources, and the efforts by teachers and school leaders to meet the professional development requirements.
