# SUBJECT: ADOPT BOARD POLICIES

BE IT RESOLVED, that the Board of Education the Board of Education adopt the following policies as presented:

- Policy 0144 Board Member Orientation/Training
- Policy 2230 Curriculum Guides
- Policy 2431 Prevention and Treatment of Sports Related Concussions and Head Injuries
- Policy 2422 Health & Physical Education
- Policy 3160 Physical Examination (certificated staff)
- Policy 3221 Evaluation of Teachers
- Policy 3223 Evaluation of Administrators, Excluding Principals, Vice Principals, and Assistant Principals
- Policy 3224 Evaluation of Principals, Vice Principals, and Assistant Principals
- Policy 3282.1 Electronic Communication by School Staff (Teaching Staff)
- Policy 4160 Physical Examination (support staff)
- Policy 4283 Electronic Communication Between Support Staff Members and Students
- Policy 4322 Staff Member's Use of Personal Cellular Phones/Other Communication Devices
- Policy 6360 Political Contributions
- Policy 7434 Smoking on School Grounds

# BACKGROUND

The above policies are being amended to ensure compliance with QSAC requirements, as well as State law.

Additionally, the following policies are amended as follows:

- Policy 0144 specifies training the Board Members should have.
- Policy 2431 ensures cheerleaders or cheerleading programs are included in the District's policy concerning the prevention and treatment of sports-related concussions and other head injuries among student-athletes.
- Policy 2422 adds specific information that should be included as part of instruction and adds specific reference to statutory requirements including but not limited to: Accident and Fire Prevention; Bullying Prevention Programs; Cancer Awareness; et.al.

- Policies 3221, 3223 and 3224 address the evaluation procedures for all teaching staff members including: classroom teachers (Policy 3221); administrators, excluding Principals, Vice Principals, and Assistant Principals (Policy 3223); and Principals, Vice Principals, and Assistant Principals (Policy 3224). All of the changes are relatively minor. Additionally, changes have been made to update the citations to the NJDOE Regulations.
- Policy 3282.1 adds social networking to electronic communication between teaching staff that is prohibited.
- Policy 4282.1 is a new policy for Electronic Communication between Support staff and Students. This policy addresses all communication protocol between support staff and students which are inappropriate and prohibited.
- Policy 4322 is a new policy which provides guidelines for all staff members on the use of personal cell phones or other communications devices.
- Policy 6360 adds government agencies and non-profits to excusals from PCD.
- Policy 7434 clarifies "smoking" and includes smokeless tobacco and vaping. It also identifies additional locations for school grounds and an additional citation.
