WHEREAS, the preliminary budget was approved by the Executive County Superintendent of Schools on April 12, 2018; and

WHEREAS, the preliminary budget was advertised in the News Record of Maplewood and South Orange on April 26, 2018; and

WHEREAS, the preliminary budget was presented to the public during a public hearing on March 26, 2018; and

WHEREAS, the total amount of the 2018-19 budget shall be:

NOW THEREFORE, BE IT RESOLVED THAT the Board of Education hereby adopts the 2018-2019 School District Budget; and

BE IT FURTHER RESOLVED THAT there should be raised for the General Fund \$118,544,891 for the ensuing 2018-19 school year; and

BE IT FURTHER RESOLVED THAT there should be raised for Debt Service Fund, \$3,701,848 for the ensuing 2018-19 school year.

BACKGROUND INFORMATION

The \$118,544,891 tax levy supports a General Fund budget of \$131,360,071. The balance of the General Fund budget is supported through state aid and miscellaneous revenues.

The \$3,701,848 tax levy supports a Debt Service budget of \$4,073,275. The balance of the Debt Service budget is supported through Debt Service aid.

The overall tax impact, including debt service is 2.30% over the 2018-19 tax levy.
