A Regular Meeting of the Board of Education of South Orange-Maplewood was held in the District Meeting Room at the Administration Building, 525 Academy Street, Maplewood, New Jersey, on March 18, 2013.

Board President Elizabeth Daugherty called the meeting to order at 7:30 p.m.

PLEDGE OF ALLEGIANCE

BOARD RECOGNITION - Read by Ms. Crawford

- Columbia High Girl's Track Team won the national championship in the 4x4 relay at the Winter Track Nationals and are New Jersey State record holders. Running at a time of 3 minutes, 42^{3/10} seconds, the team is now 5th overall in US history. Olivia Baker placed 2nd in the 400-meter at nationals, as well as set a New Jersey State record. The track team is coach by Lisa Morgan.
- 2. Columbia High School Fencing Team took the gold medal by winning the state championship match in February. Led by an undefeated performance from Bryn Hammarberg, including the clinching 26th bout, Columbia earned its third state title in four years with a 14-13 victory over Watchung Hills in the finals of the NJSIAA team tournament.

Columbia High School Girls' Fencing Team defeated Livingston, 15-12, to take the bronze medal. The girls were led by a 3-0 showing from Alexis Auer, along with Alex and Sam Viqueira.

The boys fencing teams is coached by Daryl White and the girls fencing team is coached by Ibtihaj Muhammad.

- 3. Students from the South Orange Middle School's National History Day Club won on their first visit to the National History Day regional competition, to advance to the state level competition in May and a chance to continue to the national level in Washington, DC in June. Three out of the nine SOMS entries were selected to move onto the state level and include:
 - Caroline Cerny and Piper Eccles (7th grade): Documentary about Title IX;

- Jessica Helfenstein and Zoe Fuhrman (6th grade): Performance about Women's baseball in World War II; and
- Jake Knoll (6th grade): Exhibit about the influence of fast food on American society.

Caroline Pew (6th grade social studies teacher at SOMS) is the advisor for South Orange Middle School's National History Day Club.

4. Columbia High School Robotics Teams won the NJ State Championship at NJIT for the second time in 3 years. Out of more than 75 teams in NJ, both the Varsity and the Junior Varsity teams are co-state champions along with a team from North Brunswick. The Varsity team has compiled a track record that no other public or private school in this state has been able to duplicate: 2 NJ state championships, 1 PA championship, 1 Vermont championship, 2nd place in the world (2011 - again a shared championship among 3 teams). The JV team earned its way into the state tournament and was picked to be on the alliance. The two teams went 11-1 (varsity) and 10-2 (JV) at the tournament. This is the first time in NJ history that a public or private high school has had two teams share the state championship. And no team in NJ has captured two state championships in the same year.

Allan Tumolillo is the faculty adviser to the CHS Robotics Teams.

5. Columbia High School teacher of business, Scott Cohen, took the Microsoft Office User Specialists (MOUS) courses and passed the examinations and obtained his MOUS Certification. As a result, SOMSD is now an official testing site for the MOUS Certification and gives Columbia High School students a chance to take the test and become certified as well.

Ms. Crawford announced the retirements that will be voted upon in the action part of tonight's meeting.

SUPERINTENDENT'S MONTHLY UPDATE - Dr. Osborne

Goal 1

- The District Management Council will give us a status report this evening on the reading program and other initiatives throughout the district.
- We continue to prepare for the implementation of the International Baccalaureate program at the middle schools and will have an update next month. The After School Programs doing very well. We look forward to model UN competition.
- A new pre-kindergarten ABA class opened at Clinton School. The Morris Union Jointure Commission provides support for ABA classes and was involved with the planning for this class.
- State level Report Cards now have new metrics and are called School Performance Reports and will compare schools to 30 like schools, not necessarily in same DFG or region, but each school will have its own comparison districts.
- The Music Department earned national recognition as one of best communities for music and will be recognized in April. Congratulations to all who worked on the high school's performance of Legally Blonde. It was a huge success.

Goal 2

- Another round of training for substitutes will be held.
- The second Learning Walk is taking place and will include visits to each other's classrooms followed by discussions about what was learned and how it affects teaching.

Goal 3

- Elementary parent-teacher conferences took place.
- A community wide "Big Read" was a huge success.
- Curriculum night will be held on April 4.
- Columbia High School's School in Action Night will be on April 17.
- The IT Department is updating the district website that may need some adjustments once the conversion is complete.

Goal 4

- Thanks for a detailed and thorough collaborative budget.
- Resolution 3005 has been added that opposes legislation that will have a negative impact on being able to contract for services.
- Kindergarten registration is now taking place. May 13 will begin open registration for all grades.

The contract with SOMEA will expire June 30, 2013.

Ms. Karriem noted that the Board has been reaching out to SOMEA to schedule meetings and is committed to coming to a fair agreement, however the union continues to delay the process. It doesn't seem as though an agreement can be reached in time, however the Board remains hopeful and will continue to reach out.

DISCUSSION

District Management Council

Dr. Osborne introduced Nate Levenson who gave the following status report on the work the District Management Council is doing in the district:

- Getting feedback from staff, some think the DMC is working too slowly and others too quickly. They are starting to speed up because they recognize that more people seem ready to take on more.
- Special Education Budget & Staffing Analysis Have started to monitor how teachers spend their days including respectfully asking questions without raising concerns. Soon the process will become routine.
- Expanding options for inclusion, following a similar model for gathering information. Will now return to stakeholders with information that is available so far.
- Reading intervention and inclusion are merging which is a natural process.
- Discussing time and schedules with staff and leadership. Will help identify structural changes for staff to be more productive and effective.
- Expanding how to serve students with more challenging needs by projecting what needs will be in the future.

2013-14 Budget Discussion - Mrs. Daugherty

Mrs. Daugherty gave a status report on where we are in the budget process to date.

Board member discussion followed, including, but not limited to, the following comments and questions:

- The reductions in the special education staff may be offset by reading intervention and the results of the DMC review of how time is spent.
- 2% banked cap is a guideline, however, the state included allowances for when it would be reasonable to go over the cap.
- Recommend that the Finance Committee look at options and make changes to forecast to include steps other than raising taxes.
- Work with the State to fund towns like ours that have low ratables.

TEACHNJ Act - Dr. Osborne

Dr. Osborne presented the State presentation on TEACHNJ, including the following key provisions:

- TeachNJ is tenure reform that applies to all teaching staff in NJ as of August, 2012.
- The annual evaluation and superintendent's approval for renewals will remain the same.
- The change is that Inputs of Effective Teaching and Outcomes of Effective Teaching equal a Summative Rating.
- There are to be three observations for tenured teachers an one additional for anyone with a corrective action plan.
- Student growth percentile is a State-calculated score that measures an individual teacher's ability to drive growth on NJ ASK. Student growth objective is a locally-calculated score that measures an individual teacher's impact on student achievement.
- A School Improvement Panel will oversee the new evaluation structures including mentoring and individual professional development plans, along with corrective action plans when necessary.
- Guidelines for tenure acquisition, revocation, hearings and arbitration were outlined.
- Principal evaluation is the same as the teachers' in terms of structure. Inputs are principal practice and evaluation leadership, and student teacher outcomes equal summative evaluation.
- Any collective bargaining put into place after July 1, 2013 cannot override the State regulations.
- The Excellence & Equity Committee should review the program from a public feedback perspective.

School Level Performance Targets Report - Dr. Furnari

The New Jersey Department of Education replaced the Adequate Yearly Progress (AYP) with new Progress Targets based on a student growth model for academic achievement.

- The school district adopted district goals that include a description of expectations for student growth on state assessments using this model.
- Action plans were approved for the three schools that did not meet progress targets
- Progress Target Action Plans were submitted to NJDOE including strategies to support struggling reading and math students

The committee met last week to discuss TEACHNJ and also potential gun control legislation relative to school safety. The annual Board retreat was discussed with a suggested outcome goal to have long term vision and sharing information about the achievement gap.

Engagement & Outreach - Mr. Giles

The committee met last week and reviewed a community survey and will circulate some versions to Board members. Discussed solicitation of community input on district goals and improving that process to make it easier to collect and share information. The committee recommends that the Board creates a Twitter account to share information with the community.

Excellence & Equity - Dr. Gaudelli

Reports from principals are that exciting things are going on at the middle schools such as developing learner profiles, getting more details on English Language Arts and Math acceleration for placement. Middle States accreditation is coming for the high school. The committee discussed the Lucy Caulkin and Teachers' College reading and writing workshop that point towards Common Core and the Partnership for Assessment of Readiness for College and Careers (PARCC) Assessment.

Finance, Facilities & Technology - Mrs. Wren-Hardin

The committee will meet this week and discuss capital improvement plans, long term debt service and the impact on the budget, corporate sponsorship and summer projects.

Policies - Ms. deKoninck

Policy 2412 and 2481 - 1st Reading

The committee reviewed the policies and did not have any updates to add.
